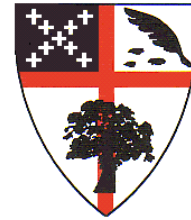

Message from the Rector

An image keeps running through my mind following last Tuesday's Bible Study.

The opening graphic for this week's discussion had two parts. The top part of the graphic shows the planet Earth with a name tag tied around it, reading "My Property! Handle with Care!" The lower part of the graphic shows a person with a name tag hanging from her neck, reading "My Property and Instrument for Service. Develop, Care For and Use Responsibly".

The point is that there is no such thing as Christian *giving*, since we can't really give away what we don't own. And since everything was made by and belongs to God, our response as Christian must be *managing, caring, and sharing*. It is a mindset and world view that we need to make our own, maybe even more appropriately now, in the midst of all this talk of financial meltdown, Wall Street collapse, and bank consolidation.

God surely doesn't expect any of us to not care what happens. But God does encourage us to keep our eyes on Him, because "trusting in God brings peace" (Isaiah 26:3). We are able to trust more and more as we gain more experience of God blessing us. Well, we have certainly seen lots of blessing in this faith family.

The City of San Jose told us that the process of granting a permit for

a pre-school can take from 3 to 9 months. It took just over two months. God provided us a special connection in Ash Kalra, Chairman of the City Planning Commission, through Wanda Bryan. The City required that we change our chain link fence along Santa Teresa Blvd to a solid wooden fence. Our friend Bill Moore of Bay Pacific Fence Co, who built the redwood fence around our parking lot, DONATED the fence and installation, and moved our project to the front of his workload, so we could meet the timing required by the City.

We needed to borrow money beyond what we have from generous gifts and grants. It usually takes a few months to get funding through the Episcopal Church Building Fund. Through my friend in the national church, Suzanne Watson, I met the ECBF President, Julia Groom-Thompson. She got us the loan in under one month. (That's the fastest loan processing they have ever done.)

We asked for a shorter time through the State licensing process. We were assigned Barbara Walker, who is a friend of Sue Nielsen (coincidence??). She took our folder home, working on it on her own time, and got our license in half the normal time.

My first contact in the Fire Department informed me that getting a fire clearance is a nine month process. Fire Inspector Lopez gave us a ONE DAY response, inspected our Classroom, and approved the fire clearance.

One more: six weeks ago I was told

Words from Your Senior Warden

I was talking with Father Ken the other day about the amazing journey we have been on this summer at St. Stephen's and how God has been with us every step of the way. When the idea of a preschool was first discussed between Ken and the wardens, it was just that, an idea. Then out of nowhere St. Stephen's school closed its doors at the end of May leaving many families without a school for fall. We stepped up our discussions to see if there was any way feasible to start a preschool by the fall term. A visit to St. John's in Morgan Hill to see Father Phil and look at their school, not only gave us great insight on how he runs the school, but he offered to share information with us on the positives and the negatives he has discovered in bringing the church and school together. Did God direct us to him? After initial discussions with the first contractor, we came away with a better knowledge of what would be needed, and discovered much of the work could be done in-house. The costs for the first contractor were higher than we felt we could manage, so we put in a call to Kent Construction, who had worked with St. John's. Not only were the costs better, he was a Christian and went out of his way to help us put together a plan to help us and put no pressure on payment. Another God moment? All through this process was it God that was guiding us, or were we just lucky?

The defining moment for me that told me that God was definitely guiding us through this process was when we presented it to the congregation. You unanimously supported the idea to bring the preschool back to St. Stephen's. I truly

felt God's guiding hand on us that day. From that day on this congregation has stepped up to the plate in every imaginable way. The strength of this community getting behind a project that will touch the lives of young children and their families has truly been touched by the Holy Spirit. It is impossible to list every person and the role they have played in a project that has been done in 4 months what realistically should have taken a year. Even when we had a few minor delays towards the end, no-one lost faith that this preschool was meant to be. There have been so many things that have happened that were out of our control, but someone or something appeared to get us to the next phase. From financial help, to work crews, whatever was needed, it was provided. The latest in this list of miracles happened just the other day. Part of our final approval process was to have the chain link fence replaced with a wooden one. Father Ken called the landscaping company that we used to see if they could do the fence. When they didn't call back right away, Ken contacted the man who had redone all our fences after the storms a couple of years ago. He came out that day gave Ken a quote, then told Ken not to worry about the numbers, he is a Christian and would like to be a part of what we are doing, so he would like to donate the fence! The guidance of God has truly been with us throughout this amazing journey.

Preschool Update...

There has been another month of amazing accomplishments toward the opening of our pre-school. Dan's Shed is nearly completed. One or two paint days will have it ready for the Fall rains. The back patio and playground area have been cleaned of the construction debris, and look **fantastic**. If you haven't taken a look, be sure to check out the children's playground area and back patio. The entire church site looks so much better! We all owe a debt of gratitude to all of the members who have worked for so many of their Saturdays to get this work done.

The San Jose Fire Inspector has given us our fire clearance. For those who like details, we are no longer an A3 facility. Due to the pre-school in the Parish Hall, we are A3 in the Worship Hall, and E3 in the Parish Hall. This change requires the strobe lights, pull boxes, additional smoke detectors, and monitor panel that have now been added.

The City has granted us our Conditional Use Permit to operate a pre-school in the Parish Hall. This new use required us to obtain a \$3,000 permit, which allows us to operate the pre-school for

I am honored to introduce to you Michael Ridgway...

As we expand our activities and raise the bar on our works of Outreach and Mission, I have been very aware of areas of leadership calling for more attention than I can provide. I have been in discussion with Michael Ridgway for over six months about his graduation from the School for Deacons, and possible assignment as deacon at St. Stephen's. He has agreed, and Bishop Mary has agreed to that assignment.

Michael will become the Reverend Deacon Michael Ridgway on November 1, 2008, Bishop Mary presiding the ordination service at Trinity Cathedral. We will be asked to support this service by providing food and drinks for the reception following the ordination. More to follow on that...

Deacon Michael will join leadership of our worship on November 23rd. We can then officially welcome Deacon Michael, his wife Kari, and son Matthew to St. Stephen's.

Following is a biography of Michael Ridgway. Take note, **he has early ties to St. Stephen's in-the-Field!** Ken +

Michael was born in Los Angeles. In 1967 his family relocated to Cupertino where they attended services at St. Jude's Episcopal. Michael served as an acolyte, was active in the youth group and was confirmed at 10 years old and was determined that one day he would become a priest in the Episcopal Church. Michael graduated from Cupertino High in 1982.

Michael's parents divorced in 1977 and his mother was remarried to Michael D. Turner a few years later at St. Stephens-in-the-Fields (Michael Turner was organist at St. Stephen's in the Fields in the early 80's just after the sanctuary was built). In fact, Michael remembers helping to paint the trim and put on the finishing touches 'way back when'. In 1983, Michael's mother, Lorelei passed away after a short illness. There is a brick donated in her memory at St. Stephens and Michael is thrilled to be seeing it much more often.

Michael moved to Placerville where he met the mother of his son, Matthew, born in 1985. After Michael's relationship with Matthew's mother deteriorated and eventually ended, Michael's life



took another dramatic change—he became a single dad at 21. The young father and son team hung together through some very lean and tough times for several years--that was until Michael found the love of his life—his wife Kari. They have known one another for over 20 years, and just celebrated their 14th wedding anniversary.

That same year, Michael graduated from CSU-Sacramento with a degree in Business Administration.

Michael, Kari and Matthew moved to the Bay Area (Kari is a Bay Area native), in 1994. For the past 7 years, Michael has been working at San Jose State University as an Analyst/Programmer. About 5 years ago, Michael began a formal discernment process in the Diocese of El Camino Real and his sponsoring parish, St. Thomas in Sunnyvale. He tested the call rigorously, attending a semester each at Fuller Theological Seminary in Menlo Park and the School for Deacons in Berkeley. He was able to discern a call to the vocational diaconate, and eventually graduated from the School for Deacons in Berkeley with Honors and will be ordained Nov. 1, 2008 at Trinity Cathedral in San Jose.

Michael is thrilled about his impending placement at St. Stephen's-in-the-Field and looks forward to meeting and getting to know the SSITF family, sharing our stories and growing in faith through our common love of our savior, Jesus Christ!

Fourteen women including, retreat leader the Rev. Karin White, met Thursday afternoon at this most scenic site overlooking the Pacific Ocean. The weather was warm and sunny. Our opening session was in the Seaview Room with spectacular views of the ocean. This was a time to clear our minds and center on the presence of God, after which we went outside to enjoy the gardens, beach and sea in quiet contemplation. We gathered for a social hour before dinner in the dining room overlooking the ocean. After dinner we returned to the Seaview Room for our evening program. Judi is working through the ordination process in our diocese, **and was just accepted as a postulant toward ordination to the priesthood.** CONGRATULATIONS JUDI!!

One begins the ordination process as a nominee. There are studies to take, conferences to attend, papers to write, and lots and lots of prayers, all leading to the Bishop making a decision to advance the nominee to the status of postulant. During her postulancy, Judi must work on a Field Edu-

cation assignment. Bishop Mary has (thankfully) assigned Judi to stay at St. Stephen's and to work with me for her Field Education work. The next step is advancement to Candidacy. That step in turn leads to her ordination as a transitional deacon, now scheduled for February 2010. A minimum of six months after that she will be qualified for ordination to the priesthood.

It is a long, deliberate path, allowing the local community to discern Judi's gifts, and for the diocese and Bishop to have done their due diligence to ensure that our clergy are the best there is. Please join with me in celebrating Judi's advancement to Postulant, and in praying for her continuing work toward ordination to the priesthood.

Executive Director, Hope With Sudan

Last June, Fr. Ken asked me if I could come up with a plan for a storage building to store the Parish Hall tables and chairs when they were not in use to free up space in the Parish Hall for the Day Care/Preschool that was then under consideration. This building should meet the following conditions:

- Be large enough to store at least the three table and chair carts
- Be not larger than 120 square feet, outside dimensions
- Be movable with minimum damage if needed in the future

Since I had a plan for a structure that met most of these conditions in my files, I told Fr. Ken, "Yes."

My plan used a series of 4' by 8' panels bolted together to build a 10' by 10' building. So I deleted two small panels and added two larger panels to get walls making the correct footprint. Then I had to redesign the roof structure. No big deal – well not quite.

After many hours at the computer terminal, I did have a plan and a materials list. At the end of the first week of August, I gave the plan and materials list to Fr. Ken and Tom Good and asked them to get the stuff on site ASAP so that I could do the millwork to have things ready for a "barn rising" August 16.

Tom did a great job at meeting my request, but our supplier, the HomeDepot, let us down. On Tuesday, August 12, **Joe Edsberg** and I went to the HomeDepot and got a pick-up load of material needed for the framing members of the walls and roof trusses. During the rest of the afternoon, **Joe Edsberg, Tom Edsberg, Jack Baird**, and I did the millwork to cut framing members to size and stack them ready for assembly crews. **Jack Baird** and I also worked on Wednesday, Thursday, and Friday on this effort.

The rest of the material was delivered to the Church on Thursday, August 14.

On Saturday August 16, we had our first workday. With the help of **Jack Baird, Felice Moniz, Bob Young, Tony and Charlie Pecora, Trig Thorsrud, Ken Redder, Andy Leif, Rod Sato, and Dan Hudkins**, all the wall panels and roof trusses were assembled and stacked ready for painting. Lunch and cold water were provided to the crew by **Lisa Thornburg, Eve Wright, and Jeanne Noteware** – that I know of. If I missed you,

please accept my apology.

After the first work day, I realized that I could not work at home, to build the door, and be at the church to work on the building. **Logan Zintsmaster** offered to build the door for me. Thank you, **Logan**.

During the week before August 23, with the help of **Bob Young**, all the wall panels were given a coat of primer paint on the outside surfaces. This was done while the landscape contractor was placing the concrete pad on which the building would be erected. On Friday, August 22, the foundation blocks were put in place; and then the site was ready for the "barn raising".

On August 23, we had our first day of real "barn raising." With the help of **Felice Moniz, Bob Young, Tony Pecora, Trig Thorsrud, Ken Redder, Rod Sato, Larry Lee, Ron and Coleman Jones**, we assembled the walls to make the shed look like part of a building. Lunch on this day was provided by **Frances Steitz**. Thank you to all of you.

At about this time, we received a complaint about the height of the roof from one of our neighbors. We stopped all further work until a plan could be worked out that would keep him happy. Once that plan was in place, it took about a week to make the design changes and another week to disassemble all the roof trusses to get them ready to be included in the new plan.

On September 20, with the help of many of the above people and **Nigel Cooper, Tim Alton, and Andy Leif**, we built the new roof trusses and added them to the top of the walls and added the lower roof panels. Lunch was provided by **Laurie Watson**.

On Tuesday September 23, **Nigel Cooper** helped me put up the last four sub-roof panels and nail down the last bundle of shingles; but we did not have quite enough shingles to complete the job. On Thursday and Friday, September 25 and 26, I brought in and installed the last of the roofing and started the many small tasks needed to complete the building of the shed.

My thanks to all of you who helped me and St. Stephen's in this building project. Each day I tried to record the names of those whom I had seen working. If I missed you, please accept my apology and my thanks for your help!

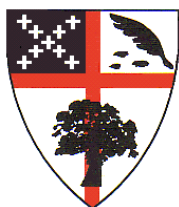
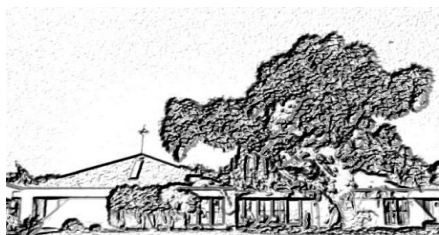
